15 The management is hereby informed that, the permission is being given purely on a temporary basis and is subject to the report of State Level Inspection and Vigilance Committee fulfilling of all the prerequisite conditions under A.P. Educational Act, 1982 and it later found that the school has not fulfilled any prerequisites as stipulated, the permission now being given is liable to be withdrawn at once.

After careful examination of the proposals received from the society and also the inspection report of the inspecting officer received vide reference 6th cited, permission is hereby accorded for Provisional Recognition for classes I to V during the academic years 2018-2019 to 2027-2028 without aid in respect of Ravindra Bharathi's Green School, Bandar Road, Penamaluru Centre, Poranki Penamaluru Mandal, Krishna District" without aid subject to the following conditions.

- 1) That the society shall abide to the rules and regulations made in the Government orders cited.
- 2) That the educational institution shall serve the needs of the locality more particularly
- 3) That the institution shall adopt the curriculum and syllabus prescribed from time to time.
- 4) The school timings, vacations and mid-term holidays shall be as prescribed by the government from time to time.
- 5) That the qualified staff within the age limits prescribed by the Government for government employees shall be appointed as per the staff pattern.
- 6) That the results of intuition shall be satisfied every year.
- 7) That the records /accounts shall be furnished to.
- 8) That the list of governing body shall be furnished to the D.E.O. every year.
- 9) That the pay stricter /fee stretcher fixed by the governing body shall be got approved by the D.E.O. every year.
- 10) That all the conditions prescribed in the G.O.s and other orders which are not specified in this orders shall be completed with.
- 11) That the schools shall not be closed without giving notice both to the parents /D.E.O and competent authority at least 6 months before.
- 12) That the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
- 13) That the society shall submit proposed for renewal of provisional recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of the renewal.
- 14) The society should renewal the fire certificate every year well in advance without fail.
